President Neil Ecker called the November 7, 2023 regular council meeting of the Biglerville Borough Council to order at 7:00 p.m.

The following council members were present: Neil Ecker, John Angstadt, Robert Smith, Janet L. Gliem, Robert Pantaleo. Robert E. Guise, Melinda Warren-Elnaggar and Mayor Phil Wagner were absent.

The following guests were present: Torren Ecker, State House of Representative; Mike Olinger, Olinger Paving; Samuel Biesecker; Citizen, Jared Winand; JDI Site Solutions, Kevin Bollinger; Sewer Operator; Chief Craig Hartley

PANTALEO MADE A MOTION TO APPROVE October 3, 2023 REGULAR MEETING MINUTES, GLIEM SECONDED THE MOTION. MOTION CARRIED UNANIMOUSLY.

### **OPPORTUNITY FOR CITIZENS TO BE HEARD:**

- Torren Ecker, State House of Representatives presented Gliem with a citation for her 31 years of service to the borough.
- Samuel Biesecker requested to council if the Borough could maintain Alley # 19 that runs along side his property. He added that it is an ordained alley and would like the alley maintained so it is easier for vehicles to travel on and pedestrians that walk the alley to walk on. Biesecker mentioned that the alley is partly paved and overgrown with grass. The paved part of the alley has potholes and signs of serious neglect. He asked if the Borough could bring this alley up to standards of the other alleys in the Borough so it can be used by vehicle traffic. Ecker asked Bollinger if the Borough has the materials and Bollinger replied yes. Samuel asked that it be taken care of by Spring and Ecker advised that since it is an ordained alley that it would be taken care of.
- Mike Olinger discussed the proposal he supplied to council on changing the contract that was recently executed to include pretreatment of roads for the upcoming snow season. Olinger advised that the benefit to using pretreatment is that it helps melt the initial snow and it would help reduce the amount of salt that is used. Brine is used as an activator, and it is more ecofriendly Olinger said. Ecker asked Olinger if the council decides later in the they wish not to do the pretreatment and if he would continue with the already agreed upon contract that was signed in October for snow plowing. Olinger advised that yes, he would he had no intentions of pulling the contract, he would honor the contract for this season. The Council made the decision later in the meeting to continue with the original executed contract, not adding pretreatment.

Biesecker and Olinger exited.

• Jared Winand provided an update to council regarding the demolition of 36 N Main St. He advised that the abatement would begin in a few weeks and will take a couple of weeks to complete. Once the abatement is complete a notification will be sent to DEP, and they will wait the 10 days that DEP provides for review. Ideally, they would like to begin the demolition in January or February.

He advised that they will be putting up a fence and placing barricades for safety. He asked the council if they had any questions about the process. After discussion, Ecker advised he appreciates the updates and to continue to update the council with progress. Winand exited

**PLANNING COMMITTEE:** John Angstadt reported that the Ridge Rentals Land Development Plans extension expires on 11/30/23.

**SEWER COMMITTEE**: Gliem read the sewer report.

Treated total 4,359,000 gallons

- Average per day 141,000 gallons
- Weekly BOD, CBOD, Phosphorus, Ammonia Nitrogen, TSS, & Fecal Coliform samples
- Weekly nitrate-nitrite & total nitrogen samples
- Monthly Copper & Final Hardness samples
- Chamberlain & Wingert guys were here the first week of this month to replace the 8" sewer main behind 52 N. Main St. that was clogged. We also had them install patches on the inside at both transitions to keep out ground water, as we tied back into the liner on the lower side.
- Control Systems 21 has ordered the decant valve for the STP, and we will schedule to replace it once it gets here. In the meantime, we are keeping the decant line full with a garden hose to eliminate the decanter popping out of the water.
- Craig Zack, Doug, and I met with Knouse Foods representatives to talk about their boiler water waste being discharged to our STP. They have some leg work and testing to do before council can make a decision.

Kevin Bollinger

- Gliem provided an update to council on the Knouse Foods metered boiler wastewater request per Craig Zack's memo. She stated the following:
  - A meeting was held on October 24th with Knouse where it was indicated that the Borough is interested in taking the waste but not any problems associated with it. They discussed potential tapping fees in addition to user fees and an agreement should the waste ever be decided to be accepted.
  - They discussed what DEP will require from the Borough to approve acceptance of the waste and Knouse was provided with a list of contaminants that DEP requested to be analyzed for. It was decided that two samples will be taken for an average and that the Borough will be involved in the collection of the samples.
  - After the sampling and analysis is completed, the results will be reviewed to determine if pretreatment is necessary and summarized and sent to PA DEP for approval.

GLIEM MADE A MOTION TO ACCEPT THE CONTROL SYSTEMS QUOTE FOR THE DECANT VALVE REPLACEMENT IN THE AMOUNT OF \$2,412.50, FREIGHT AND INSTALL IS ADDITIONAL. SMITH SECONDED THE MOTION. MOTION CARRIED UNANIMOUSLY.

### **WATER COMMITTEE:** Rob Smith read the water report

In October our water system pumped a total of 2,514,000 gallons averaging 81,097 gal/day. That is an 12.2 % decrease from September 2023 and a 4.6 % decrease from October 2022.

October's bacteria samples were taken on the 2<sup>nd</sup> at 33 Musselman Ave. (G.V.M.), 366 Arendtsville Road (Nutrien)

(boro office), 374 Heidlersburg Road

October had one final water meter reading, 125 Fourth Street.

Out at the Appleview development, on October 9<sup>th</sup> we charged the water main lines, then on the 10<sup>th</sup>, we flushed the lines preparing them for Total Coliform test. The test results came back good.

On the 10<sup>th</sup> Chamberlin &Wingert repaired a water leak at 360 East York Street. We lost about 50,000 gallons till we got the leak fixed. Doug called them at 2 pm, they were there in less than 2 hours. This leak gave us no notice and needed to be repaired that day. Chamberlin &Wingert did a good job as always.

In October, Ketterman's Electric finished installing the receptacles at both Wells (#6 &#7) and the generator. The next step is doing a test run soon. When we do this if anyone wants to come out let Doug know.

One of our Chlorine analyzer (DR300) stopped working, it needs replaced. Doug needs councils' approval for the purchase. A quote is attached.

In October, Ault paving paved the four water leak repairs. They did a good job.
